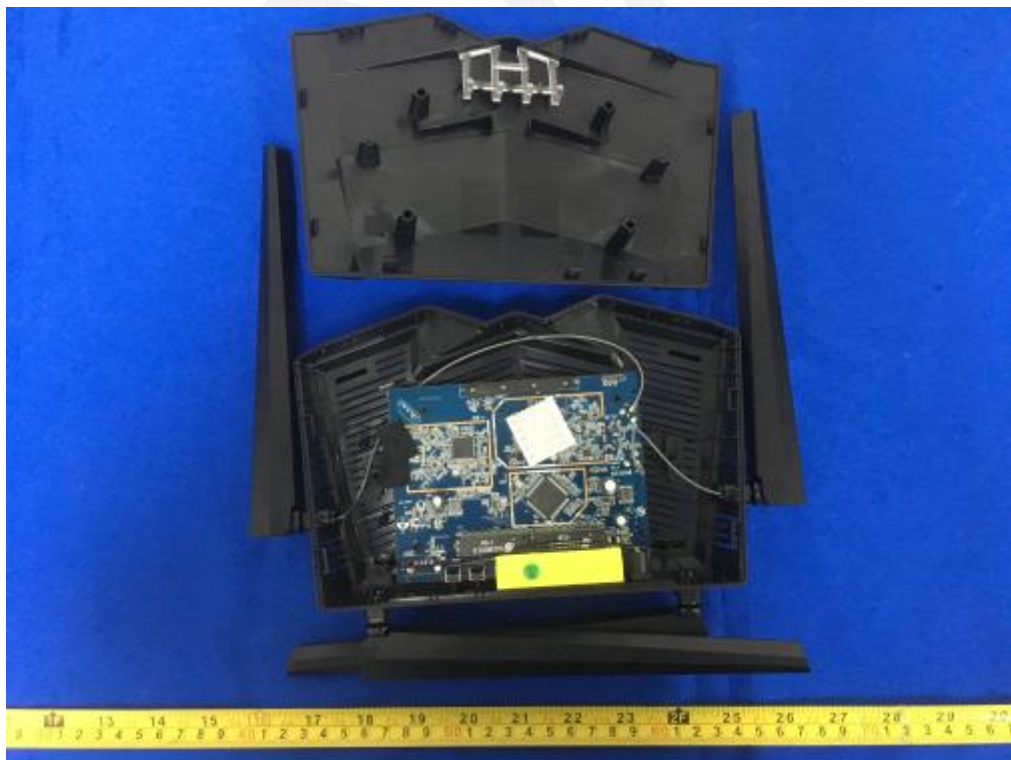

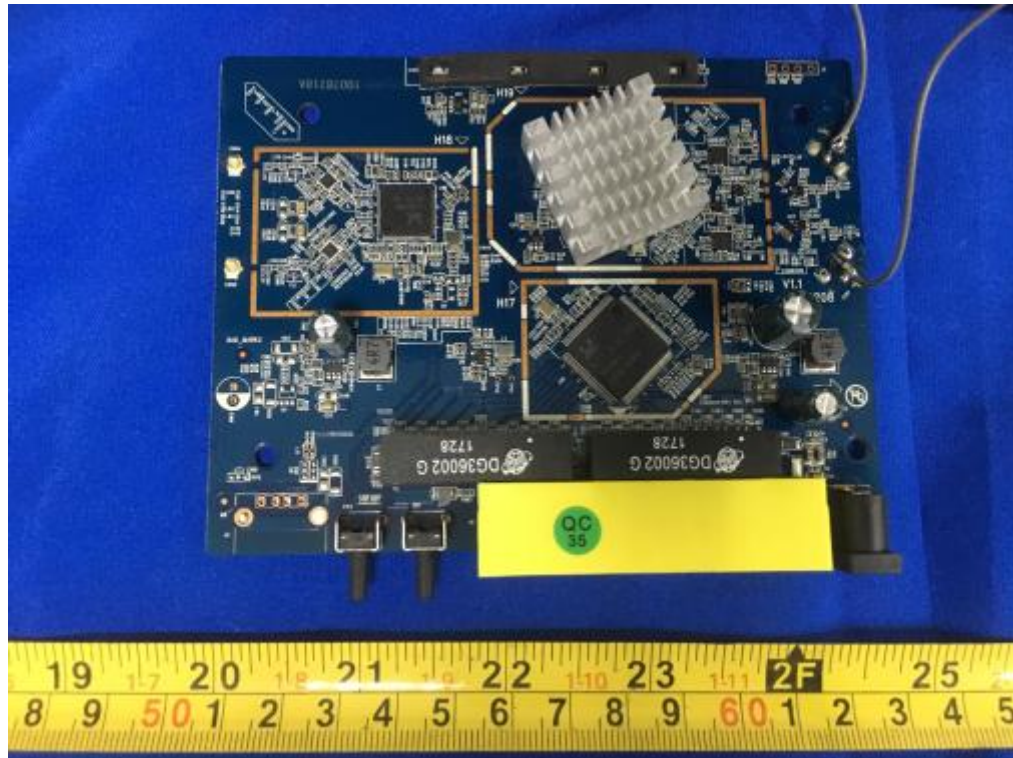


Photo 5 PCB top view

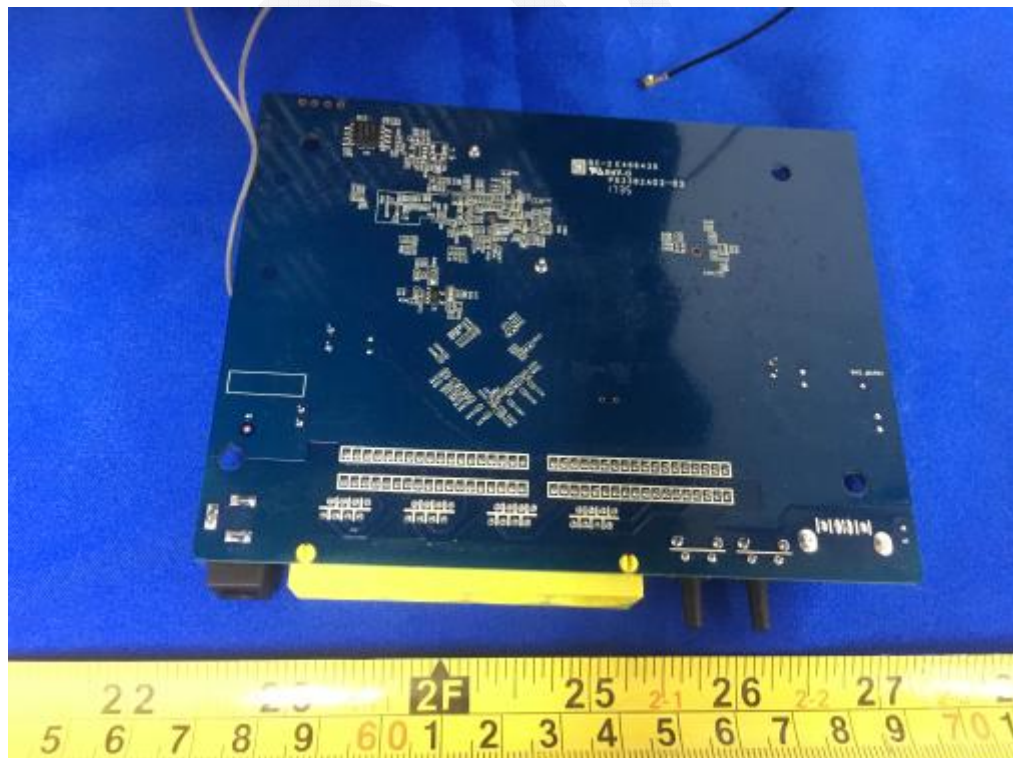
